-Ballot Question Committees-**

**A Ballot Question Committee must submit the following statements in 2019 unless it is eligible for and requests a reporting waiver prior to the close of the books for the applicable filing deadline.**

**2018 ANNUAL CAMPAIGN FINANCE STATEMENT REQUIRED**

Public Act 119 of 2017 has reinstated the annual reporting requirement. A 2018 Annual Statement is required to be filed by all committees EXCEPT those committees that maintain a reporting waiver or file a Post-Election Campaign Finance Statement in December, 2018.

File the following statements. If your committee supports or opposes a ballot proposal on a 2019 ballot, it must file a pre- and post- election statement in accordance with the election date listed below in lieu of a quarterly statement.

**May 7, 2019 Election:**

**\*\*Late Contribution Reports Period from: April 22-May 4, due 48 hours after receipt.**

**August 6, 2019 Election:**

Pre-Election	July 21, 2019	July 26, 2019
Post-Election	August 26, 2019	September 5, 2019

**\*\*Late Contribution Reports Period from: July 22-August 3, due 48 hours after receipt.**

**November 5, 2019 Election:**

Pre-Election	October 20, 2019	October 25, 2019
Post-Election	November 25, 2019	December 5, 2019

**\*\*Late Contribution Reports Period from: October 21-November 2, due 48 hours after receipt.**

**\*\* Late contribution reports are required when \$2,500 or more is contributed by a single contributor during 15<sup>th</sup> to 3<sup>rd</sup> day prior to election. They are NOT waived by the reporting waiver.**
