-Candidate Committees-

A Candidate Committee must submit the following statements in 2019 unless it is eligible for and requests a reporting waiver prior to the close of the books for the applicable filing deadline. Determine the schedule that applies to your committee and file the statements accordingly.

2018 ANNUAL CAMPAIGN FINANCE STATEMENT REQUIRED

Public Act 119 of 2017 has reinstated the annual reporting requirement. A 2018 Annual Statement is required to be submitted by all committees EXCEPT those that maintain a reporting waiver or file a Post-Election Campaign Finance Statement in December, 2018 and Incumbent Judges or Justices.

Table with 3 columns: 2018 Annual Statement, Close of Books, Statement Due Date. Values: December 31, 2018; January 31, 2019.

Schedule A - Candidate WILL appear on a ballot in the 2019 calendar year:

May 7, 2019 Election:

Table with 3 columns: Close of Books, Statement Due Date. Values: April 21, 2019; April 26, 2019; May 27, 2019; June 6, 2019.

**Late Contribution Reports Period from: April 22 - May 4, due 48 hours after receipt.

August 6, 2019 Election:

Table with 3 columns: Close of Books, Statement Due Date. Values: July 21, 2019; July 26, 2019; August 26, 2019; September 5, 2019.

**Late Contribution Reports Period from: July 22-August 3, due 48 hours after receipt.

November 5, 2019 General Election:

Table with 3 columns: Close of Books, Statement Due Date. Values: October 20, 2019; October 25, 2019; November 25, 2019; December 5, 2019.

**Late Contribution Reports Period from: October 21-November 2, due 48 hours after receipt.

Table with 3 columns: 2019 Annual Statement, Close of Books, Statement Due Date. Values: Due unless November post-election statement due/submitted in December, 2019; December 31, 2019; January 31, 2020.

** Late contribution reports are required when \$500 or more is contributed by a single contributor during 15th to 3rd day prior to election. They are NOT waived by the reporting waiver.

Schedule B - Candidate WILL NOT appear on a ballot in the 2019 calendar year:

Table with 3 columns: Statement, Close of Books, Due Date. Values: July Statement; July 20, 2019; July 25, 2019; October Statement; October 20, 2019; October 25, 2019; 2019 Annual Statement; December 31, 2019; January 31, 2020.
